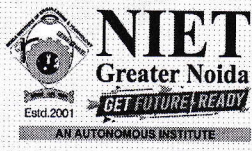
## NOTICE

### M. Tech. Final Year Dissertation/ Thesis Submission & Viva-Voce Examination

All the students of M. Tech **Second Year** (Session: 2021-22) are hereby informed that their Even Semester (4<sup>th</sup> Semester) **Dissertation/ Thesis Viva-Voce Examination** will be conducted in **Offline mode** from **01/07/2022 to 30/07/2022** for those who have submitted their Dissertation/ Thesis on or before 15/07/2022. The viva-voce examination will be conducted after the evaluation & approval of Dissertation by internal evaluation committee along with compliance of following norms:

#### Eligibility for Dissertation/Thesis Submission:

1. The medium of expression for the dissertation shall be English language.
2. The dissertation shall satisfy the following conditions:
  - a) It should be satisfactory as far as its scientific/technical/literary presentation is concerned.
  - b) The dissertation shall be typed as per the prescribed format and specifications. (Guidelines for Dissertation/ Thesis preparation are available on institute website in Academics dropdown).
  - c) The dissertation should be submitted along with the 'Originality Report' using anti-plagiarism software e.g. Turn it in or similar software. The student shall also provide a certificate of non-plagiarism duly countersigned by the dissertation supervisor/ guide. The department will forward the M. Tech thesis along with Turn it in or similar software plagiarism check report having similarity less than 20 %.
  - d) It is presumed that a candidate would endeavor to present quality work in the dissertation leading to get the results published in one International Journal (SCI/SCOPUS indexed/ Web of Science) or two UGC Care Journal papers or two International conference papers (e.g. IEEE reviewed conference or equivalent). The thesis evaluation panel will give due consideration on this point while awarding marks for dissertation.
  - e) The dissertation shall be typed as per the prescribed format and specifications. For the final submission of Dissertation, at least 3 Presentation must be conducted by the department. Dissertation
